You agree not to engage in any of the following activities:

- Placing fraudulent bids or using automated bidding systems (bots).
- Listing prohibited or illegal items.
- Manipulating or attempting to manipulate the auction process.

- Engaging in any activity that may interfere with the operation or security of the Platform.
